

#### How to Wear Cloth Face Coverings

Cloth face coverings are an additional step to help slow the spread of COVID-19 when combined with every day preventive actions and social distancing in public settings.

Who should NOT use cloth face coverings: children under age 2, or anyone who has trouble breathing, is unconscious, incapacitated or otherwise unable to remove the mask without assistance.

Cloth face coverings are NOT surgical masks or N95 respirators. Currently, surgical masks and N95 respirators are critical supplies that should be reserved for healthcare workers and other first responders. It's official; DD-214's are NOW Online. Please pass on to other Veterans.

THE NATIONAL PERSONNEL RECORDS CENTER (NPRC) has provided the following web site for veterans to gain access to their DD-214s online:

<u>http://vetrecs.archives.gov/</u> or try <u>http://www.archives.gov/veterans/military-</u> <u>service-records/</u>

This may be particularly helpful when a veteran needs a copy of the DD-214 for employment purposes.

NPRC is working to make it easier for veterans with computers and Internet access to obtain copies of documents from their military files. Military veterans and the next of kin of deceased former military members may now use a new online military personnel records system to request documents.

Other individuals with a need for documents must still complete the Standard Form 180, which can be downloaded from the online web site.

Because the requester will be asked to supply all information essential for NPRC to process the request, delays that normally occur when NPRC has to ask veterans for additional information will be minimized.

The new web-based application was designed to provide better service on these requests by eliminating the records center's mail room and processing time.
