You may already do this, but if not, consider using your word processor as a diary.

Besides serving as a possible memory aid, you can use the diary to list events, addresses, phone numbers, people, URL's email addresses, and past (captured) photos for later reference.

Your word processor can then be searched for something that happened time ago, and items can be accurately copied, pasted, printed, emailed, etc.

You could then tell someone who you spoke with (employee ID and even the time), date, data such as Vin #, model, phone number, FAX, maybe login and password, installation date, company, etc.

You would have handy contact via Web address and mailing address, if needed.

You might think of other uses for your diary, but this is perhaps a useful start. It may take time, at first, but well worth it.

80th National Pearl Harbor Remembrance Day Commemoration

Each year in the United States, National Pearl Harbor Remembrance Day honors all those who lost their lives when Japan attacked Pearl Harbor on December 7, 1941. More than 3,500 Americans lost their lives or were wounded on that solemn day.

HONOLULU– Pearl Harbor National Memorial, Navy Region Hawai'i, and Pacific Historic Parks have announced the theme for this year's National Pearl Harbor Remembrance Day Commemoration: Valor, Sacrifice, and Peace. This year marks the 80th commemoration of the attack on Pearl Harbor on December 7, 1941, and the subsequent entry of the United States into World War II.

The goal of the commemoration and supplemental events is to ensure that future generations will understand the valor and legacy of those who perished and those who fought throughout the war. The commemoration also highlights the importance of the peace that brought a reconciliation that continues to create a better future for all.

American Flags are flown at half staff until sunset, December 7, 2021.

THE FLAG

I get upset watching football games where parachutists land, dragging our flag along the ground. Our finance officer, John (Mac) McMillan sent this item, sort of along the same lines:

I served in the Army (I volunteered, not drafted) from 1968 until 1971, and served as an Army medic in-country in Vietnam for all of 1970. Following college, I then served in the Navy from 1975 until 1998. I enjoy seeing all the American Flags that fly in The Georgia Club neighborhoods. I'm sure I'm like other veterans who appreciate and respect the Flag etiquette that is given from sunrise to sunset. Unfortunately, even the American Flag at our post office isn't provided the respect the Flag deserves after sunset. "According to the <u>U.S. Flag Code</u>, Section 6a: "It is universal custom to display the flag only from sunrise to sunset on buildings and on stationary flagstaffs in the open. However, when a patriotic effect is desired, the flag may be displayed twenty-four hours a day if properly illuminated during the hours of darkness. The <u>American Legion</u> interprets 'proper illumination' as a light specifically placed to illuminate the flag (preferred) or having a light source sufficient to illuminate the flag so it is recognizable as such by the casual observer." Ambient light from a porch light, street light, or moonlight, is not considered proper illumination because the intent is not to shine light on a flag. Maybe this Veteran's Day at least the post office American Flag should be directly illuminated to respect our country and all Americans. And it would be a nice gesture to bring American Flags inside at sunset if they are not illuminated. After dark and in darkness the flag looks as forlorn as just a piece of forgotten laundry. Happy Veterans Day America!

FROM ED, A SOLDIER'S CHRISTMAS
